The Role of the Board-Certified Clinical Nutritionists (C.C.N.) in Health Restoration!

(Part 1 of 3) [Biochemical Testing & CN Therapy Restores Health!]

After reading this 3-Part article, you will understand why every healthcare professional would want to be a C.C.N., if not already. In Part 1, I will share the origin, role, and value of the C.C.N. profession in health restoration and disease prevention. This is evident by the ongoing increase in self-help publications and authors, of both self-help to health-related academic textbooks, who are referring their readers to the C.C.N. for professional guidance in implementing the nutrition and dietary education in their books and for help with more complex nutritional biochemistry health challenges.

Board-Certified Clinical Nutritionists (C.C.N.) have the academic degrees, post-graduate training, national board certification, and up to or over 42 years of clinical nutrition experience in successfully meeting the public's clinical nutrition needs; up to 32 years, if calculating only from the date of board certification.

Therefore, Part 1 provides an introduction for readers not yet "up-todate" on the valuable and successful

healthcare profession of Clinical Nutritionists ...founded in the 1980s by a group of nutritional healthcare professionals aware of the growing demands for healthcare professionals who could provide healthy solutions for the rapidly increasing number of people suffering from nutrition-related symptoms of degenerative diseases. Hence, the profession of the Certified Clinical Nutritionist (C.C.N.) was officially established, with their first board-certified examination, in 1991; the year I was board certified.

Briefly, Taber's Medical Dictionary defines "Nutrition" as the 'sum processes of digestion, absorption, and metabolism of food substances (diet and supplementation) for the growth, repair and maintenance of the human body.' In other words, these processes of nutrition are required to get the nutrients from your food (diet and supplements) into your cells. Otherwise, your organs, glands and body systems become malnourished and once you have

more malnourished, decayed and dead cells and tissue, than healthy ones, in this degenerative process, diseases are diagnosable. However, the public can suffer for de-

> These preceding stages in the process of developing a degenerative disease are organ/ gland dysfunctions caused by biochemical imbalances and other adverse nutrient-related factors, such as toxicity and "insufficient to clinical" levels of nutrient deficiencies and/or excesses. In these preceding stages, it requires less time, money and effort to stop this degenerative disease process by restoring your health and thus preventing diseases, all together.

Clinical Nutrition has become so mainstream that some years ago, the terms "Functional Medicine" and "Orthomolecular Medicine" were introduced to help the public understand Clinical Nutrition because for decades the term "Nutrition" [Clinical Nutritionists (C.C.N.)] has been used interchangeably with the term "Diet" [Dietitians], even

though these two terms and their related-healthcare professions, respectively, are distinctly different. (Refer to the first article I wrote for The Villager in March 2021, "Are You Confused By Nutrition Today?")

The diverse C.C.N. education includes sciences in many, if not all, of the following: biochemistry, physiology, molecular biology, herbology, homeopathy, naturopathy, psychology, endocrinology, pathology, and oncology. Board-Certified Clinical Nutritionists (C.C.N.s) are trained to utilize several disciplines to successfully achieve the therapy required to support individual health.

For example, many C.C.N.s are already certified, licensed and/or degreed as healthcare or disease-management professionals in other disciplines, such as medical physicians, osteopaths, chiropractors, dentists, naturopaths, homeopaths, pharmacists, acupuncturists, mental health professionals, podiatrists, optometrists, veterinarians, nurses, etc., in addition to those with a Ph.D. in Clinical Nutrition, like myself. These professionals discovered that the addition of clinical nutrition testing and therapy into their existing practice will, in many cases, aid in rapid health restoration and disease prevention. For professionals, who are also Board-Certified Clinical Nutritionists, you will find C.C.N. after their primary post-nominal abbreviations. For example, M.D.,

(PGSCN requirement may be waived as these degrees include its core science and nutrition courses.)

3. Advanced Professional Degree in a Licensed Healthcare Field, such as an M.D., D.O., D.C., N.D., etc., PLUS the PGSCN program.

The PGSCN program includes 56 additional hours of core science and nutrition courses, such as Anatomy & Physiology, Human Biology, Chemistry, Biochemistry (pre-requisite Organic Chemistry), Microbiology, Nutrition I & II Introduction, Nutrition & Disease, Nutrition & Supplementation, Nutrition Assessment, Herbology, Nutrition Counseling Strategies and Nutrition & Aging.

The C.N.C.B. renewal criteria include Continuing Education Units (CEU) like the board certifications, licensing or registrations of other healthcare professions, however, unlike other professions, the C.N.C.B. also requires re-ex-


amination every five years, i.e., we prove to the public by "re-examination" that C.C.N.s stay "up-to-date" in clinical nutrition and related research.

The Role of the Board-Certified Clinical Nutritionists (C.C.N.) in Health Restoration! (Part 2 of 3)

[C.N. Biochemical Testing & Therapy Restores Health!]

Did you read Part 1 of this 3-Part article published in *The Villager* on January 19, 2023? The C.N.C.B. (est. 1991) is a non-profit, tax-exempt 501(c)(3) certification agency providing professional training, examina-



tion, and board certification to Certified Clinical Nutritionists (C.C.N.), just like the Federation of State Medical Boards (FSMB Est. 1912) and the National Board of Medical Examiners (NBME Est. 1915) provide licensing for physicians and the Commission on Dietetic Registration (CDR Est. 1969) provides registration for Dietitians. The C.C.N. Scope of Practice has become a legal standard for conduct in the practice of Clinical Nutrition.

The International and American Associations of Clinical Nutritionists (I.A.A.C.N.) provides post-graduate training and continuing education units (C.E.U.) for C.C.N.s. I am honored to be currently serving on the Board of Directors for the I.A.A.C.N. [IAACN.org]. Their quality Continuing Education is also applied for annually by the American Clinical Board of Nutrition, Texas Chiropractic College, Ed-

ucation Review Systems, various state agencies and professional associations.

As referred to in Part 1,

the value of the C.C.N. has

become so essential and "mainstream" that just 11 years after the C.N.C.B. provided the first Board Certified Clinical Nutritionist (C.C.N.) examination (1991) and 95 years (1917) after being known as the American Dietetic Association (A.D.A.), the A.D.A. changed its name to the Academy of Nutrition and Dietetics (A.N.D.).

Though also trained in Dietetics, the profession of the Board-Certified Clinical Nutritionist (C.C.N.) includes doctors and healthcare professionals of all specialties who have qualified and passed the C.C.N. examination, whereas A.N.D.'s qualifications to become a Registered Dietitian are exclusive to Dietitians, with the minimum qualification of a Bachelor's Degree in Dietetics [https://www.cdrnet. org/rd-eligibility]. Our diverse educational training may account for Dietitians becoming Board Certified Clinical Nutritionists (C.C.N.), also.

In Part 3, I will provide the degrees and post-graduate

requirements of the Clinical Nutrition Certification
Board (C.N.C.B.) to become a
Board-Certified Clinical Nutritionist (C.C.N.), which by the
way, includes re-certification by
examination.

The C.C.N. profession is the only healthcare profession, whose professional certification, licensing or registration board includes re-examination in their Renewal Criteria. In other words, the Renewal Criteria of the Clinical Nutrition Certification Board (C.N.C.B.) includes re-certification by re-examination every five years; thereby, proving to the public that C.C.N.s stay up-to-date in the latest clinical nutrition and related-research in their profession.

Renewal by re-examination is a requirement, I am confident, that the Public would appreciate in all professional Renewal Criteria. Exploring the cure for disconnection

Loneliness and isolation are a huge social challenge especially after dealing with

the Covid epidemic. Although mental health has many complexities, remedies may be within our grasp. Loneliness does not only affect our minds but also our overall

health and well-being. Lack of social connection is a predictor and risk factor for strokes, heart disease, obesity, early Alzheimer's, and even premature death. Loneliness and isolation are an antecedent to substance abuse and addiction. Research suggests loneliness causes serious pain acting on the same parts of the brain as physical pain. The cycle of loneliness, isolation, trauma, and pain is the starting point of many social challenges including homelessness.

When researching loneliness, focus groups were utilized among cross cultural groups of individuals, a surprising discovery was that many who described themselves as lonely were married and had relatively large networks of friends or family. It was the feeling of loneliness that was explored. One can be in a crowd and still feel lonely. Individuals and love songs have described that the loneliest place to be is in an unconnected relationship.
Loneliness depends more

on the quality of a person's relationships than on their sheer number.

Many of us crave solitude, which feels renewing and peaceful when

desired. When solitude is

not a choice, the pain of isolation in a family or group may make us more likely to lash out at the people from which we feel alienated. This becomes a negative feedback loop that is hard to escape. According to neuroscientists, the cure for this is to recognize and articulate the need for closeness and connection. Sharing one's fears, passions, gifts, talents, life experiences, vulnerabilities, life challenges, hopes and dreams is the beginning of knitting hearts together. Being authentic with one another and assisting one another with empathy, kindness and compassion is the beginning of closeness. Acceptance, emotional safety, and respect are essential if one is to become connected. Belonging to a group that shares life goals and values is a key element to combatting loneliness and

isolation.
Researchers, searching

for an answer to this ageold question of quality of life and longevity discovered a remote village in the heart of Sardinia, Italy where more people live to be 100 than anywhere in the world. Sardinians live in a social fabric that is tightly knit together. The Sardinian town square is the hub of the community. One must go through it to get to the market, post office, church, or pharmacy. This "Piazza" is the glue that makes it easy to interact and know your neighbors. Developers are creating this "Piazza" type town which started with the 55 and older community design. Clubhouses, community centers, parks, and town squares are a trademark of these communities making it easier to connect.

Other strategies to cultivate connection are to join community groups, learn social and emotional skills to be able to share your vulnerabilities and life struggles, ask one another questions and appreciate individuals' life stories, get to know neighbors by scheduling a community event, have meals together, limit screen time in favor of face time, be intentional and slow down long enough to listen with our heart. These strategies will increase connection, happiness, and health and decrease loneliness and isolation. joneen@ myrelationshipcenter.org
